



## **Unity University Office of the Registrar Student's Commitment Form**

Applicants who wish to join Unity University are strongly advised to abide by the following rules and regulations and also fulfill the criteria enumerated below:

### **1. Entrance Criteria:**

#### **1.1. For Graduate Studies Programs**

- Holder's of Bachelor Degree from recognized Higher Education Institutions (HEIs) in a related discipline with an overall CGPA of at least 2.00 and passing entrance exam.

#### **1.2. For Undergraduate Programs**

- Completion of preparatory education and passing 'University Entrance Examination' with current Ministry of Education (MoE) cutoff points.
- Holding a Diploma from a recognized College/University with appropriate certification approved by MoE.
- Holding Level IV certificate, completion of 10<sup>th</sup> /12<sup>th</sup> grade, one year of work experience, COC at level IV (Pass) and pass in Bridging exam prepared by HEIs.
- Higher Education equivalence from HERQA.
- Transfer from recognized HEIs.
- Degree holders from recognized HEIs.

### **2. Applicants are required to bring with them:**

- 2.1. Original Transcripts, Diploma or Degree Copies along with photo copies of each.
- 2.2. Three (3) colored passport size photographs.

2.3. Official transcript to be mailed directly to the Office of the Registrar of Unity University in four (4) weeks time after admission. Failure to do this shall result in the denial of graduation and claim for re-imburement.

### **3. Tuition and other fees to be paid:**

3.1. Initial registration and application fee, tuition fee, module fee and payment for laboratory and other services.

3.2. Applicants who wish to discontinue their admission to the University will be treated with the following deductions:

- Application fee and 10% of their tuition only if their appeal is presented within two weeks after class begin.

3.3. Installment/Monthly payers who fail to settle their fees will accrue a penalty fee of birr 10.00 everyday lapsed.

***N.B. The University may be required to change the payment when necessary (Payment is subject to change)***
